

Evidence shows that man-made global warming is a hoax

The Brits have figured it out - manmade global warming is a farce - and Climategate has been instrumental in revealing the fact that data has been twisted to say something other than the truth. The recently released British Social Attitudes report surveyed U.K. consumers and found that they are no longer willing to pay the extra money to go “green” because of their skepticism of man-made climate change. Here are some of the findings of the survey.

The number of people willing to pay extra to go green has dropped from 43 percent to 26 percent since 2000. That included people of all income groups.

Forty-three percent of the people surveyed consider climate change to be dangerous to the environment, a reduction of 50 percent since 2000.

Thirty-seven percent of those surveyed considered that “environmental threats were exaggerated,” an increase of 24 percent since 2000.

U.K. consumers, despite their changing opinions of global warming, are not unconcerned about the environment. A large majority of them recycle and have reduced their home energy and water consumption, but only about 20 percent have reduced driving their cars.

A recent report by Climate Depot entitled, “Climate Depot Special Report: A-Z Climate Reality Check” claims that “The scientific reality is that on virtually every claim - from A-Z - the claims of the promoters of man-made climate fears are failing, and in many instances, the claims are moving in the opposite direction.”

Examples given in the report: Antarctic sea ice is expanding, not contracting as proponents of man-made climate change claim. Arctic ice is also expanding. Polar bears are thriving, not dying off. Sea levels are actually dropping. Global temperatures have remained constant for more than a decade, and some scientists are now claiming that we face global cooling, not warming.

Proponents of man-made global warming have held that cholera and malaria would escalate due to global warming, but this has not happened. They also claimed that there would be more hurricanes and cyclones and that more deaths from extreme weather events would occur. This also has not happened.

Much has been made of the notion that the amount of CO₂ released into the atmosphere is responsible for global warming. This has led to attacks on industrialization and automobiles, as well as corrupt schemes to increase taxes. But the report points out that normal climate changes are the result of hundreds of factors, not solely CO₂. The report said, “It is not simply the sun or CO₂ when looking at global temperatures, it is the sun, volcanoes, tilt of the earth’s axis, water vapor, methane, clouds, ocean cycles, plate tectonics, albedo, atmospheric dust, atmospheric

circulation, cosmic rays, particulates like carbon soot, forests and land use, etc. Climate change is governed by hundreds of factors, or variables, not just CO2.”

Two years ago, an article in the UK News was entitled, “Climate Change is Natural: 100 Reasons Why.” Perhaps it has played a part in the change of attitudes of U.K. consumers. Here are a few examples from that article.

“Man-made carbon dioxide emissions throughout human history constitute less than 0.00022 percent of the total naturally emitted from the mantle of the earth during geological history.”
“Warmer periods of the Earth’s history came around 800 years before rises in CO2 levels.”

“After World War II, there was a huge surge in recorded CO2 emissions, but global temperatures dropped for four decades after 1940.”

“A large body of scientific research suggests that the sun is responsible for the greater share of climate change during the past hundred years.”

We here in America are facing the most pivotal time in our history with the upcoming elections next year. The Obama Administration, his czars and federal agencies have continued to push the environmental issues, leading us to make extremely consequential decisions in legislature and policies. If Obama is re-elected, this will most certainly result in more regulations and higher taxes, making our economic recovery an impossibility.
