






The Speaker Assigns Bills to Committees. The Floor Leader Controls the Bills.



HB 3028 OK Energy Security Act

- "Demand side management the management of <u>custon</u> <u>consumption of electricity</u>, demand for electricity, thro implementation of:
- a. load management or dema resource technologies, management practices or strategies in residential, commercial, industrial, inst or government customers electric loads from periods higher demand to periods of lower demand, or
- 3. "Energy efficiency" means technologies, management practices or other strategies in residential, commercial, institutional, or government customers that reduce electricity use by those consumers.

SMART GRID INVESTMENT GRANTS

"(B) SMART ELECTRIC METER.—For purposes of subparagraph

(A), the term 'smart electric meter' means any timebased meter and related communication equipment which is capable of being used by the taxpayer as part of a system that—

"(i) measures and records electricity usage data on a time-differentiated basis in at least 24 separate time segments per day,

"(ii) provides for the exchange of information between supplier or provider and the customer's electric meter in support of time-based rates or other forms of demand response,
